This year was a fruitful year for collaboration, with women based community institution, however the year ended with Covid19 crisis which has impacted the life of tribal families, as most of the families depended on the income coming through migration to other town and cities.

Gramshree in collaboration with SRIJAN is working as facilitator for Van Dhan Vikas Kendra, under Pradhan Mantri Van Dhan Vikas Yojana. This Kendra has been selected as one of the Model Van Dhan Vikas Kendra.

We would like to acknowledge the support received from Buddha Fellowship Program, India Friends Association, USA California, Women on Wings and FICCI ladies Organization, Jaipur.

Gramshree has come up with leaps and bound and has reached stage, where next 3 years, become very crucial for its growth. We look forward to serve the tribal families, with similar support from our well-wisher in coming future.






1. Geographical Outreach

Gramshree has been working in Kotra and Gogunda Block of Udaipur Rajasthan from last 3 years'. In collaboration with is social start-up, it has been able to impact the lives of 2,500 tribal families. Gramshree Foundation Trust is directly working in 50 villages of two block with process of mobilizing women in Self Help Group and Producer Groups and Producer Organization.

During this unprecedented Covid Crisis Gramshree Foundation Trust supported 1,400 Families with dry ration support and created awareness in around 50 villages with distribution of more than 2000 mask and 2500 hand washing soap. Awareness generation was also created through wall painting and demonstration at the village level.





2. Initiative taken by Trust to minimizing impact of Covid.

Immediately after lock down was announced by the Govt. in response to Covid-19 pandemic, Gramshree did assessment of the conditions of the ultra-poor families residing in the Kotra, Gogunda and Shayara Block of Udaipur Rajasthan. The most critical challenge among the families was lack of liquid money to purchase the food materials. Area is mostly dominated by schedule tribes, they have very small land holding and are dependent on the labour work for the cash income. Most of the families' male member either work in the nearby town and cities like Sumerpur, Pali, Udaipur, Abu, Jodhpur or they work in other states cities like Ahmedabad, Rajkot and Surat. Due to lock down there was no cash income and whatever they have got was exhausted or going to be exhausted.

a) Distribution of Dry ration to the neediest families which includes the migrant who came back, widow and destitute:

Dry ration kit was provided to 1,400 families in Kotra and Gogunda Block of Udaipur Rajasthan. Kit constitutes of essential item for a family of 4 members for 15 days.

Gramshree received support from local functionaries like Sarpanch, ward members and SHG members in identification of the needy families















b) Awareness Camp:

Awareness camp was organized covering 40 Village and 2000 population. Vehicle was used to disseminate the awareness creation, which was fitted with Audio system, creating awareness to the tribal population in the local language. It covers symptom of the covid-19, means of protection which included importance of wearing mask, hand wash and social distancing. It also provided information to tribal families, whom to contact if they suspect any symptom of Covid-19. Practical demonstration was provided on hand wash in each villages.

3. Progress on Formation of Producer Company of tribal

Gramshree have started the formation of producer group which will be federated in to Producer Company.

Each Producer group comprises of member in range of 10 to 15. We have formed 8 Farmers Producer group. Meeting is being conducted on fortnightly basis. Till date Rs 28,000 has been mobilized as share capital from 38 members. Each member is contributing Rs 500 for share capital and Rs 100 for expenditure on getting producer company registered legally.

This producer company will take the role of procurement and production of custard apple pulp and Gramshree will focus on sale and providing the technical support.



Gramshree is planning for cultivation of organic vegetable with 20 farmers in next 6 months. On success of this pilot we would like to scale it to 300 famers in this area. This will open additional income for the tribal in this area. We are expecting to add additional income in the range of Rs 5,000 to 10,000 through this

5. "Health is Wealth".

Gramshree Foundation Trust with support from FICCI ladies' organization, Jaipur, organized a health camp at Piplikheda village in Kotra block of Udaipur on July 16, 2019. There was a huge response from community. Women, men and kids underwent general health checkups, eye checkups and understood about basic illnesses. Around 120 women, men and children participated in the camp.

A team of gynecologist, ophthalmologist and health attendants from Jaipur and Udaipur region participated in the camp.

6. CASE STUDY:

a) Young girl Anita Grashiya from Dang Village, worked as incharge in the processing unit. She is first girl in the village who is pursuing the higher studies in a private college in Block Headquarter. She earned Rs 7,000 from sale of fruit and by working in the processing unit. She used Rs 5,000 for paying the fees of the college and some money for the purchase of book.

Custard Apple season is live a festive season for the tribal in this area. They wait for the season to some to complete the pending task like repair or construction of home, to pay back the any loan, to get back the jewelry mortgage to money lender. This is season when they are able to earn the cash income.



Smile speaks the most, the value of little money they are able to earn. This may be very little to those living in the cities, but for these tribal it brings the smile in their face.



b) Keli baijiu, village Thimbleberry, Kotra, Udaipur, age-50years plus, came to Grasmere's village processing unit in the search of work. Seeing her age and very less chances of learning skills of processing, team wasn't sure, how and what she could do?

While exploring further, she needed the work badly as she lives alone and has no sources of income. Thus, a role was designed to suit her skills and capabilities. She is really enthusiastic and excited about this opportunity. Smile in her face brings happiness to us all.





7. Field Visit by External Visitor: India Friends Association, USA California

Representative of IFA Mr. Rajesh and Ms. Joyti visited the field on December 10-11 2019. They interacted with group of women who were part of SHGs doing saving and internal lending. This has built a platform in the villages through which women are able to get the money at the time of crisis. Now they do not depend on the money lenders to get the money. Many members who have mortgage their jewelry before the formation of SHGs, have not got back their jewelry.

This SHG is also acting as point of sale of Custard Apple for them. Earlier they used to sale the fruit at the rate of Rs 100 per cerate. Now they are receiving Rs 200 to Rs 250 per cerate, after formation of SHG and Gramshree intervention in custard Apple value chain.

Further Visit was done to all 3 processing units run by Gramshree at Dang, Jhadoli and Sarmathura. They met with Vinita and came to know, how she is using the earning received from sale of fruit and working in processing unit for her education.

Gramshree has acted on the suggestion provided by Rajesh ji to explore the opportunity for these women in stitching. Gramshree got in touch with organization SADHNA in Udaipur which works with women on stitching and hand embroidery. They can provide the work order for these women if they are trained in these skills. We are currently exploring the financial support for providing training and hand holding support to a group of 100 women.











8. Accreditation received during 2019 -2020

Processing unit established by Gramshree has been selected as "**Model VAN-DHAN KENDRA**" in Gogunda Block of Rajasthan under PRIME MINISTER precious scheme of **VAN DHAN YOJANA**, **under which 3,000 VAN DHAN KENDRA** are being promoted with financial support of Central Government across the country with focus of doubling the income of Tribal families.

9. Fellowship & Incubation Support: Buddha Fellowship Program

Rakesh Gupta, Trustee of Trust was supported by Buddha Fellowship program. Program provided input for the Trust in form of quarterly clinic in which expert from different sector provided input on different aspect of the organization building.

Buddha fellowship program covered Gramshree intervention and made a movie of the whole movie. It covered the journey of Gramshree and captured the process of production of custard apple pulp.

Gramshree also received support from BFP for seeking the grant support from IFA. It was of great help for Gramshree.
